Explanatory information for the signatory

What is this consent for?

The consent authorises Griffith University to record and use your copyright material, image, recording and name, together with information about your participation in a Griffith University event. It allows use by Griffith University, and if the Griffith University use is public, it allows others to reuse it. The consent covers the entire or partial use of your copyright material, image, recording and name in conjunction with other media (e.g. text, audio and visual). It also allows us to transfer the recording into other formats. For example we may place the recording on websites, brochures, reports, advertising, internal documents or podcasts. Griffith University may use the recording for commercial or non-commercial purposes.

What is your copyright material?

It may be your script and/or written work, performance, recordings, websites, art, images.

What are moral rights?

As well as copyright you also have moral rights. These are that if we reuse the recording in which you appear, we cannot use it in a way that is detrimental to your integrity and reputation. We confirm that we will not use the recording in any way that is detrimental to your reputation and integrity but we may not necessarily attribute you in any reuse.

What happens to the consent form once it is signed?
